- V. Superintendent's Report
  - 1. Substitute Pay Mike reported that the substitute pay will need to increase to meet the new hourly rate. The new rate will be \$80.00 and \$85.00 per day.
  - 2. Maine Tuition Rates Mike noted that by year end, December or in January, the State sets the new tuition rate for next year. Our rate went from \$16,000 to \$20,000, an increase of \$4,000 which is a big increase. The increase has nothing to do with the formula but due to the roof expense and tractor purchase. Mike noted that this is just a one year jump and the tuition rate will decrease again next year. Barry and Mike plan to attend the next Coplin School Board meeting to answer any questions that they may have. George Joseph has already been notified of the increase. It was also noted that both Coplin and CV will not be billed the new rate until September of 2020.

Mike also noted that due to the increase in the tuition rate, he would not be recommending an increase in taxes this year.
