Safety Considerations

Working with the State, the CDC and our School Physician, there are numerous things to be implemented, including the following; face coverings/shield for all students and staff; ongoing cleaning and sanitizing throughout the day and after school; the isolation of students that present symptoms and parental pickup. A re-entry plan for a safe return to school; safety measures in place for transportation to and from school.

Changes to the Facilities

Assessment of all classrooms to determine Social Distancing
Maintenance Room moved to the laundry Room
Social Worker office moved to the Maintenance Room
Pre-k moved from Kindergarten Room to Social Worker office
Cafeteria moved to the Gym
Steel drums moved to the Cafeteria
Splitting grades 3 and 4, Grade 3 moves into Steel Drum room
Special Education Room moved to Title I and conference rooms to set up the School Isolation Room
Isolation Room established for short time evaluation/isolation with parent pick up at the side door.

Transportation

Parents are going to be encouraged to bring students to school. The bus protocols will limit the number of students and additional runs might be necessary. High School student transportation will be provided and we will work with SAD 58 to determine numbers.

Scheduling

Middle School

Moving to Blue/White block schedule that will minimize classroom movement. Specials may be provided in classrooms, in the gym or outside. Students will report to homerooms in the morning and breakfast will be provided in the homerooms. Currently, classrooms can accommodate social distancing to provide in-school instruction.

Elementary students will report to classrooms when entering the building unless they are eating breakfast. Classrooms will continue self-containment except for specials which is similar to middle school.

The general flow of traffic will be staggered to maintain social distancing. Grades 5-8 will use the back door to exit/enter for recess and PE, Grades 3-4 will use the side door and Grades Pre-K to Grade 2 will use the front door. Parents will enter the building only to the main office.

The Lunch schedule will divide into three lunches- two for the elementary and one for the middle school.

In-school and Distance Learning

Stratton School will start with regular classroom instruction (based on current numbers) but will also imbed the resources/tools/applications in case we need to go remote. There will require additional training and increased responsibilities of support staff to assist with instruction as feasible.

Parents and students will have the option of remote learning that will be overseen by the Remote Learning Coordinator with the classroom teacher's direction. The remote learning will be offered for Grades 2-8 and will be tailored to meet grade level and individual student needs.

The Remote Learning Coordinator (RLC) will work with teachers, students and parents providing instruction via web-based programming and individualized packets of work. The RLC may have flexible hours to meet student and staff needs. Students may join individual classes via Zoom for specific content as the situation allows with RLC follow-up.

Staffing

Split grades 3 and 4, hired a 3rd grade teacher.

Adding Ed Tech support for each class to assist with additional services/requirements

Hired a new Pre-K position

Creating a Distance Learning Coordinator (DLC) position for Grades 2-8

Additional staff for cleaning/sanitizing
